### Source and Supply -

The lake volume is approximately 885 AF and no restrictions are in effect. The Pine Ridge Ditch ran off call water to Lake Durango and Amber reservoirs from March 1<sup>st</sup> to the 15<sup>th</sup>. Amber reservoir is now full with 43 af. The valve stem for the Amber drain valve needs to be replaced. The Pine Ridge Ditch Co. annual meeting was held on March 4. PRDC Secretary/Treasurer Art Gresh passed away and the other PRDC officers are working to straighten out administration.

#### Treatment

February water production was 4,552,000 gallons.

#### Distribution

Estimated February water sales are 2,719,674 gallons. Most meters without radios were read.

## 6. Source Water Project Update

The project was put out to bid on March 11 and the bid open date is scheduled for March 31. The project utilizes the County ROW and a change order will be issued to relocate the pipeline to private property if all of the easements are obtained prior to construction. It appears that most of the CR 141 property owners are on board with allowing easements in exchange for a treated water line being installed with no other compensation. Bud has prepared a draft Agreement to be sent to their attorney, LPWWA and the Tribes.

Ron moved to make tap purchase available to the land owners offering easements at a cost of no more than \$14,000 for up to ten years, Mike  $2^{nd}$ , Approved.

The County L&E meeting was held on March 10. The planning commission recommended the project.
